

**NAIC Vendor Electronic Filing Submission Directive
as adapted for Washington-only filings with the Office of Insurance Commissioner**

A. Naming Convention for ASCII Text and PDF Files

Following is a description of the composition of the names for PDF and TXT files.

- 1) The file name can vary in length, but will have a suffix extension of **“.PDF”** for Adobe Portable Document Format files or **“.TXT”** for text files.
- 2) The file name to the left of the suffix extension consists of the following fields, which are delimited by an underscore (“_”) character. The letters are not case-sensitive. The first eight fields must be identical to those of the ZIP file.
 - a) Company code that is composed of five digits
 - b) Two-digit primary vendor code
 - c) One-character statement type code
 - d) Four-digit filing year
 - e) One-character submission filing type code
 - f) One-character submission group type code
 - g) One- or two-digit version number code
 - h) One- or two-digit separate account ID
 - i) Two-character state supplement code
 - j) One- or two-character filing blob type code

The general form of the file name is **ccccc_vc_s_yyyy_f_d_vv_sa_ss_fb.ttt**.

ss	Two-character State Supplement Code. If the PDF or TXT file is a Washington-only file (those in the filing BLOB type code section below), then this field MUST be " WA ". For the uniform NAIC PDF and TXT files, this field MUST be " NA ".	
fb	The filing BLOB type code. PDF files use symbols starting with a "P", while the email response text file uses the <i>EM</i> symbol. Valid Washington-only codes are listed below.

B. ZIP File Naming Convention

Following is a description of the composition of the ZIP file name.

- 1) The ZIP file name can vary in length but will have a suffix extension of **“.ZIP”**.
- 2) The file name to the left of the **“.ZIP”** extension consists of the following fields, which are delimited by an underscore (“_”) character. The letters are not case-sensitive.
 - a) Company code that is composed of five digits
 - b) Two-digit primary vendor code
 - c) One-character statement type code
 - d) Four-digit filing year
 - e) One-character submission filing type code
 - f) One-character submission group type code
 - g) One- or two-digit version number code
 - h) One- or two-digit separate account ID
 - i) Two-character state supplement code
 - j) One- or two-digit ZIP file sequence number

The general form of the file name is **ccccc_vc_s_yyyy_f_d_vv_sa_ss_zz.ZIP**.

ss	Two-character State Supplement Code. Must use "WA" for domestic RBC filings. Otherwise, the OIC accepts ZIP files with either "NA" or "WA". Users may add Washington-only PDF and TXT files into uniform NAIC ZIP files for any submission group type code except "R".	
zz	Two-digit ZIP file sequence number. This number uniquely identifies different ZIP files that use the same first eight fields as another ZIP file. Valid filing sequence numbers are 1 through 99. A leading zero may be supplied but is not required for numbers 1 through 9.	
.ZIP	The file name extension identifies the file as a ZIP file.
