**NOTICE OF PREHEARING

This matter has been scheduled for a telephonic prehearing conference to be initiated and convened before the undersigned administrative law judge (ALJ) from the Office of Administrative Hearings at 3:00 p.m., Pacific Time, Thursday, June 29, 2006.

The prehearing conference has been scheduled pursuant to RCW 34.05.431 and WAC 10-08-130(1) for the purpose of setting the hearing schedule and to consider:

- (a) Simplification of issues;
- (b) The necessity or desirability of amendments to the pleadings;
- (c) The possibility of obtaining stipulations, admissions of fact and admission of the genuineness of documents which shall avoid unnecessary proof;
- (d) Limitations on the numbers and consolidation of the examination of witnesses;
- (e) Procedural matters;
- (f) Distribution of written testimony and exhibits to the parties prior to the hearing;
- (g) Such other matters as may aid in the disposition or settlement of the proceeding.

The presiding officer may also consider any unresolved issues concerning discovery. RCW 34.05.446(3).

The names, addresses and telephone numbers (if available) of the parties to whom notice is given and their representatives are attached and incorporated herein by reference. RCW 34.05.434(2). **The parties shall notify the Office of Administrative Hearings with an appropriate telephone number where they can be reached for the conference.**

Parties who fail to attend or participate in the hearing or other stage of the adjudicative proceeding may be held in default. RCW 34.05.440(2).

ORDER

IT IS HEREBY ORDERED That the telephonic prehearing conference shall be convened in the adjudicative proceeding now pending at 3:00 p.m., Pacific Time, Thursday, June 29, 2006. The conference call will be initiated by the administrative law judge.
