Executive Summary

In 2007, the Washington state Legislature modified the definition of "health plan" in <u>RCW 48.43.005</u> to exclude fixed-payment insurance plans that are offered as a stand-alone benefit. Under <u>RCW 48.43.650</u>, the Office of the Insurance Commissioner (OIC) must collect and report information regarding fixed-payment insurance on June 1st of each year.

The law exempts these products from complying with many mandated benefit requirements that apply to comprehensive medical insurance. Because this coverage is not comprehensive health insurance and the benefit amounts may be significantly less than the cost of care, insurers must provide a disclosure form to help consumers understand that the coverage will not pay the entire cost of most medical expenses or hospital care. The companies must use a standard disclosure form, which they must file with the OIC for approval.

Fixed-payment insurance policies pay a specific amount to people who receive certain types of medical care or services. Fixed-payment plans make these payments regardless of the actual amount of charges. For example, a plan might pay \$200 a day for each day that a consumer is in the hospital. Insurers sell these policies to individuals and to employer groups.

Group fixed-payment policies allow employees to buy coverage through their employers. Under a typical benefit design, there is a set dollar amount for a doctor visit—such as \$25 per visit—or a daily benefit amount for a hospital stay—such as \$200 per day. There is also a low calendar-year maximum. These payments usually cover only a fraction of the actual cost of medical services.

Proponents of the 2007 change testified that employers wanted to provide this limited coverage to their low-wage and seasonal employees to provide employees an option for some coverage. Opponents expressed concern that some employers would replace comprehensive medical coverage with these very limited plans, resulting in enrollees incurring uncovered medical costs or deferring treatment.

Since 2009, the OIC has conducted an annual survey of the insurers that offer fixed-payment insurance policies and has reported its findings to the Legislature. The enclosed report for June 1, 2022, is a result of the survey that the OIC sent to companies in January 2022. The companies reported data for the 2021 calendar year. In this report, we compare the 2021 data with data we collected in 2020, 2019, 2018 and 2017.

Annual Report

Survey

Each January, the OIC requires companies to complete a survey and submit data about their fixed-payment insurance policies. The survey questions are:

- Did you write fixed-payment policies in Washington State in 2021?
- Number of new fixed-payment policies issued in 2021 group?
- Number of new fixed-payment policies issued in 2021 individual?
- Number of new fixed-payment policy group enrollees in 2021?
- Number of new individual fixed-payment policy enrollees in 2021?
- Total number of enrollees on all fixed-payment policies as of December 31, 2021?
- Total number of existing fixed-payment policies in force as of December 31, 2021?
- Number of complaints from consumers that the Washington state Office of the Insurance Commissioner forwarded to the company regarding fixed-payment policies in 2021?

Data Summary

RCW 48.43.005 defines fixed-payment policies as specified disease or illness-triggered fixed-payment insurance, hospital confinement fixed-payment insurance, or other fixed-payment insurance offered as an independent, non-coordinated benefit. The benefits pay a fixed dollar amount to the insured person regardless of the actual amount of medical costs.

In 2021, we saw a slight increase in the numbers of companies writing fixed-payment policies. 48 companies reported that they sold fixed-payment policies to consumers as compared to 45 in 2019.

In 2021, Companies recorded 53 complaints as compared to 145 complaints in 2020.

Number of Companies that wrote Fixed-Payment Policies in WA




Figure 1: The total number of companies that wrote fixed-payment policies in WA increased slightly in 2021 from 45 to 48 (6.7% increase).

Number of Consumer Fixed-Payment Plan Complaints filed with the OIC




Figure 2: Companies reported a total of 53 consumer complaints in 2021. Compared to the 2020 count, the 2021 total shows a 63.4% decrease (change of 92 complaints).

Group Market

- The 2021 survey indicates that 27 companies had active group polices with an increase of 56,427 (246.4%) group enrollees compared to the prior year. The 2020 survey showed that 20 companies sold group policies, with a decrease of 34,821 enrollees on new group policies from 2019 to 2020.
- The top 10 companies in the group market with a total of 75,310 new enrollees (96% of all new group enrollees):

Seven companies reported fewer than 1,000, but more than 200 new enrollees:

- Principal Life Insurance Company: 909

- o The Guardian Life Ins. Company of America: 438
- o Transamerica Life Insurance Company: 388
- o The Lincoln National Life Insurance Company: 376
- Unum Insurance Company: 308
- Assurity Life Insurance Company: 224
- Ten companies reported between 1 and 200 new group enrollees, for a combined total of 483 enrollees (0.68% of all new group enrollees).
- Out of the 48 companies that did write fixed-payment policies in WA in 2021, 25 wrote group fixed-payment policies.

Individual Market

The market for fixed-payment insurance coverage does not meet the definition of a comprehensive health plan or the requirements under the Affordable Care Act (ACA) (Pub. L. No. 111-148 (2010)) and does not meet the ACA's requirement to purchase minimum essential coverage.

• In 2021, 30 companies sold 40,065 individual fixed-payment policies. In 2020, 31 companies sold a total of 29,505 individual policies (an increase of 35.8% individual policies sold from 2020 to 2021).

- In 2021, 10 companies issued 93.2% of all new individual policies sold in Washington, covering 51,387 individual enrollees.
- One company, American Family Life Assurance Company of Columbus dominated the individual market in Washington, with 10,239 new policies (28.6% of all new individual policies), and 18,215 new individual enrollees (33.6% of all new individual enrollees). This is a slight increase in from 2020, when American Family Life Assurance Company of Columbus reported 12,276 new individual enrollees.

The number of companies that are actively selling new individual fixed-payment policies decreased from 31 in 2020 to 30 in 2021. Fourteen companies reported decreases in new individual enrollees.

Total Number of WA Fixed-Payment






Figure 3: Companies reported a total of 316,583 policies in force. Compared to the 2020 cumulative totals, the 2021 cumulative policy totals show a 2.9% increase (9,058 policies).

Plan Enrollees




Figure 4: Companies reported a total of 908,361 enrolled members. Compared to the 2020 cumulative totals, the 2021 cumulative enrollment totals show a 38.0% increase (250,183 total enrollees) in overall enrollment. **Source:** Company responses to the OIC survey for 2020, 2019, 2018 and 2017 benefit years. Data is reported based on benefit year, not survey year.

Fixed-Payment Policy Complaints

Across all 48 companies that wrote fixed-payment policies in 2021, there were 53 recorded complaints from consumers reported to the Washington Office of the Insurance Commissioner. This is a large reduction from previous years, with 145 complaints in 2020 and 103 complaints in 2019. The complaints reported in 2021 were all from 12 companies, with the top 3 accounting for 62.3% of all complaints.

Results Comparison

The 2021 survey data show that the number of new individual enrollees has increased by 24.4% from last year, while the number of new individual polices has increased by 21.4% from last year. The number of group policies and enrollees saw an even larger increase between 2020 and 2021, with a 369.8% increase in policies and a 246.4% increase in enrollees. This significant increase is largely attributable to one company, Combined Insurance Company of America, which issued 35,757 group policies in 2021, up from 68 group policies in 2020.

The growth in the fixed-payment enrollment from 2020 to 2021 of 38.0% is greater than the enrollment increase of 18.1% reported 2019 to 2020. This increase is not reflective of more companies writing fixed-payment policies, but instead of a larger number of enrollees and policies per company. Because policyholders can include spouses and dependents on their policies, there are a greater number of enrollees than policies. In 2021, across all companies, there was an average of 2.87 enrollees per policy, up from 2.14 in 2020, and 1.6 in 2019. Despite more enrollees, there has been a decrease in the number of complaints.

Total Number of New Individual and Group Policies




Figure 5: The total number of both individual and group policies increased from 2020 to 2021. Group policies saw the largest increase (369.8%), whereas the number of individual policies increased by a smaller margin (21.4%).

Total Number of New Enrollees - Individual and Group Policies




Figure 6: The total number of both individual and group enrollees increased from 2020 to 2021. Group enrollment saw the largest increase (246.4%), whereas individual enrollment increased by a smaller margin (24.4%).
