Introduction

In 2006, the Washington state Legislature enacted comprehensive health care liability reform,¹ requiring attorneys to report medical malpractice settlement data to the Office of the Insurance Commissioner (OIC). Each year, the OIC must post summary statistics about medical malpractice lawsuits that are resolved.² RCW 7.70.140 does not have tools for the OIC to use to require attorneys to report data. Voluntary compliance has been poor and data in this summary are incomplete. The OIC cannot draw conclusions from incomplete data, so this statistical summary is limited to calendar-year statistics.

There are two types of data displayed in this statistical summary:

- **Total paid indemnity:** Total compensation paid by all defendants to the claimant stemming from a lawsuit. Indemnity payments may come from several defendants if a lawsuit named more than one party.³
- **Legal expenses:** All sums paid by the claimant to the attorney to prosecute the claim, including attorney fees, expert witness fees, court costs, and all other legal expenses.⁴

Key 2021 medical malpractice lawsuit statistics

- Attorneys reported 11 lawsuits were resolved with paid indemnity in 2021.
- In cases where indemnity payments were made to the claimant, average compensation to the claimant was \$2.7 million.
- Average attorney fees were \$972,438.

Total legal expenses

- Claimants must pay fees and costs to file a lawsuit regardless of whether they receive a settlement.
- The average legal expense in 2021 was \$1 million per reported lawsuit, a 139.6% increase from 2020.

Indemnity payments to claimants

- In 2021, attorneys reported 11 lawsuits in which a claimant received compensation.
- The average indemnity payment was \$2.7 million, a 135.4% increase from 2020.

Attorney fees

- Claimants pay attorney fees based on their contracts, and these fees are related to the total indemnity paid to the claimant to resolve the lawsuit.
- The average attorney fee in 2021 was \$972,438 per reported lawsuit with attorney fees, a 147.5% increase from 2020.
