RE: ShareFile Access - Year 4 of OIC K-12 Health Benefit Data Collection Project

Hello again from the OIC K-12 project team.

The purpose of this message is to provide important information about ShareFile to School district personnel that will be directly involved in submitting health benefit data in response to Year 4 of OIC K-12 Health Benefit Data Collection Project. Persons that will not be directly involved in submitting health benefit data via ShareFile can ignore this message.

Data submission method is ShareFile.com

In Year 4 of the project, ShareFile.com will again be used as the data transport mechanism. Information on this service may be found on the ShareFile website, which is www.sharefile.com. If you have specific concerns about the data security arrangements of ShareFile.com, please see www.sharefile.com/industries/business/security.aspx.

Once you are logged in, the ShareFile site contains extensive help functions and tutorials that are accessible via the 'Help' function in the upper right-hand corner of any screen.

ShareFile Access

If you are a new ShareFile user, please either contact the project team to be set up with access your district's ShareFile account, or have someone from your district (who already has access) do so. Note that all users have authority within their own school district's account to add or delete other district users, to upload or download files, and to configure the email notifications that are automatically generated whenever files are uploaded or downloaded.

If you are an existing user of ShareFile (if you used ShareFile to submit data in Year 3 of the project) you can log on to ShareFile using the credentials that were set up previously. For security reasons you may want to consider changing your password. If you have forgotten your password, go to the login page, enter your email address, and Click on "Forgot Password?". You will be taken to a screen where you can reset your password.

Timelines / Next Steps

01/19/16	Individual ShareFile accounts have been set up for all districts.
1/28/16	The District Data Call, consisting of a Data Collection Spreadsheet and an Instructions document, will be sent to all school districts and also posted to the OIC's web site.
5/31/16	Deadline for all data submissions.
