An examination of the financial condition of **HEALTHPLEX OF WA, INC.** (HPW) as of September 30, 2012 was conducted by examiners of the Washington State Office of the Insurance Commissioner (OIC). HPW has applied for a Washington certificate of registration as a limited health care service contractor (LHCSC). Findings in Examination Report. The Commissioner adopts as findings the findings of the examiners as contained in pages 1 through 5 of the report.


## CONCLUSIONS
