**BACKGROUND**

An examination of the financial condition of **WORLD VISION, INC.** (WV) as of September 30, 2012 was conducted by examiners of the Washington State Office of the Insurance Commissioner (OIC). WV holds a Washington certificate of exemption to issue charitable gift annuities. This examination was conducted in compliance with the laws and regulations of the state of Washington and in accordance with the procedures promulgated by the National Association of Insurance Commissioners and the OIC.
