

1. DISCUSSION

- 1.1 The Office of the Insurance Commissioner ("OIC") and Respondents Commonwealth Land Title Insurance Company ("Commonwealth") and Lawyers Title Insurance Corporation ("Lawyers") stipulated and agreed that the above-captioned proceedings should be dismissed pending final resolution of the common legal issue also raised in the parallel case captioned *In re Chicago Title Insurance Company*, Docket No. 2008-INS-0002 (OIC No. D07-308).
- 1.2 The terms and conditions agreed upon are set forth in the STIPULATION AND ORDER FOR DISMISSAL WITHOUT PREJUDICE, attached and incorporated herein as Attachment A.

2. ORDER

- 2.1 NOW THEREFORE, it is hereby ordered that this matter is dismissed without prejudice pursuant to Washington Administrative Code (WAC) 10-08-230.



**STIPULATION AND ORDER
FOR DISMISSAL
WITHOUT PREJUDICE**

I. STIPULATION

The Office of the Insurance Commissioner ("OIC") and Respondents Commonwealth Land Title Insurance Company ("Commonwealth") and Lawyers Title Insurance Corporation ("Lawyers") hereby stipulate and agree that the above-captioned proceedings should be dismissed pending final resolution of the common legal issue also raised in the parallel case captioned *In re Chicago Title Insurance Company*, Docket No. 2008-INS-0002 (OIC No. D07-308). That legal issue is: Whether, in Washington, title insurers can be subjected to regulatory enforcement action for alleged violations of WAC 284-30-800 committed by the insurers' appointed agents (hereinafter the "common legal issue").

While the present Commonwealth and Lawyers matters have not yet determined the common legal issue, the Administrative Law Judge in the *Chicago Title* case has already entered an initial order deciding this issue in the insurer's favor. The OIC has petitioned the

1 OIC Hearing Officer for review of that initial order, the parties have provided briefing and
2 oral argument, and a ruling from the OIC Hearing Officer is expected in the near future.

3 In order to address these cases' common legal issue in the most efficient manner
4 possible, the parties now stipulate to the dismissal of each of the above three referenced
5 proceedings against Commonwealth and Lawyers, subject to the following terms:

6 1. The dismissals are without prejudice.

7 2. Following the dismissals, and after a final determination of the common legal
8 issue has been reached in the *Chicago Title* case, and any timely appeal therefrom, the OIC
9 may unconditionally file new Notices of Hearing for any or all of the allegations contained in
10 the Notices of Hearing currently filed in these matters against Commonwealth and Lawyers.

11 3. The OIC agrees to standstill and not file new Notices of Hearing for any or all
12 of the allegations contained in the Notices of Hearing currently filed in these matters against
13 Commonwealth and Lawyers until final determination of the common legal issue in the
14 *Chicago Title* case, and final determination of any timely appeal therefrom.

15 4. Should the OIC elect to file new Notices of Hearing, it shall do so within 120
16 days after the final determination of the common legal issue in the *Chicago Title* case.

17 5. Should the OIC elect to file new Notices of Hearing, no statute of limitations
18 shall apply to impede or prevent the filing(s) and the new Notices of Hearing will be deemed
19 to relate back to the date when the original Notices of Hearing were filed.

20 6. Should the OIC elect to file new Notices of Hearing, nothing in this stipulation
21 shall be construed to affect Commonwealth's and Lawyers' rights to have the matters
22 presided over by an administrative law judge as provided by RCW 48.04.010(5).

23 7. The dismissals shall in no way or for any reason operate or be deemed as an
adjudication upon the merits.
