A hearing was scheduled in this matter on Friday, February 27, 2009, at 10 a.m. On Wednesday, February 25, 2009, the Licensee, Sung H. Kim, aka Charlie Sungho Kim, requested by electronic mail to continue the hearing date of February 27, 2009, due to a death in the family. On Thursday, a telephone conference was held regarding Licensee's request for a continuance. Sung Kim appeared pro se by telephone. The Insurance Commissioner appeared pro se by and through Charles D. Brown, Senior Staff Attorney in his Legal Affairs Division.

During the telephone conference, Mr. Brown expressed the Commissioner's concerns that this is the Licensee's second request to continue the hearing date during which time a




stay is in effect, allowing the Licensee to work as an insurance agent. The Commissioner requested that the Licensee's insurance license be suspended pending the outcome of the hearing in this matter. Sung Kim agreed to the suspension of his insurance license and that he would refrain from acting as an insurance agent until entry of the final decision after hearing. With the agreement of the suspension of Sung H. Kim's insurance agent's license, it was further agreed by the parties to continue the hearing until Wednesday, March 25, 2009.

Based upon the above activities,

IT IS HEREBY ORDERED that, by agreement of the parties, the insurance license of Sung H. Kim is suspended immediately pending the outcome of the hearing in this matter.

IT IS FURTHER ORDERED that the hearing is continued until Wednesday, March 25, 2009, at 10 a.m., in conference room 151, of the Office of the Insurance Commissioner, 5000 Capitol Boulevard., Tumwater, Washington, and shall continue on succeeding days until terminated.
