TIG is a California domiciled stock insurer and an indirect subsidiary of Fairfax. Northbridge Indemnity will provide the company with certain claim handling services. RiverStone Resources, LLC will provide reinsurance recovery, financial, actuarial and other management services.

The ultimate controlling parent company of the Registrant is Fairfax Financial Holdings Limited ("Fairfax"), which owns indirectly 100% of the outstanding common shares of TIG.

ORGANIZATION CHART


