On March 8, 2010, Ralph R. Bargabos filed a Demand for Hearing to contest the Insurance Commissioner's (OIC) Order Revoking License, No. D10-0045, dated March 2, 2010 (Order). Said Order revokes the insurance agent's license of Ralph R. Bargabos (Licensee).

Accordingly, on April 8, 2010, the undersigned held a first prehearing teleconference in this matter to discuss procedure to be expected during the hearing process, and the parties agreed to a May 6, 2010 hearing date.

The hearing was subsequently continued to May, 27, 2010 to accommodate the schedule of Ken Combs, identified as a witness by both parties, but scheduled to be out of the country for a period that included the May 6, 2010 hearing.

On May 26, 2010, the OIC requested and the Licensee agreed to a second continuance based upon the availability of Mr. Combs, who had been dealing with a seriously ill family member. Due to these unforeseen circumstances, the undersigned finds good cause to continue the hearing.

**ORDER**

Based upon the above activity,

IT IS HEREBY ORDERED that the hearing in this matter is continued from May 27, 2010 until **Thursday, June 10, 2010**, commencing at **11:00 a.m.** in the Office of the Insurance Commissioner, 5000 Capitol Boulevard, Tumwater, Washington 98501.
