STIPULATION AND ORDER

Pursuant to RCW 34.05.060 and WAC 10.08.230(2)(b), the parties hereby stipulate and agree as follows in resolution of this matter:

STIPULATION

1. On March 25, 2010, May 7, 2010, and June 9, 2010, the Commissioner sent to the licensee, Kenneth Jepson, at Mr. Jepson's address on file with the Office of the Insurance Commissioner, written requests that the licensee submit a replacement finger print card.

2. When Mr. Jepson did not submit a replacement finger print card, the Commissioner entered Order No. 10-0126 dated July 14, 2010, revoking Mr. Jepson's producer license effective August 3, 2010, for failing to respond promptly to inquiries from the Commissioner in violation of RCW 48.17.475.

3. Prior to August 3, 2010, Mr. Jepson requested a hearing to contest said Order, by virtue of which request said Order was automatically stayed.


4. Mr. Jepson and the OIC have agreed to resolve this matter as follows: (1) Mr. Jepson will pay a fine of \$250 to the OIC which fine payment will be due within 90 days of August 9, Stipulation and Order 1



1 2011: (2) Mr. Jepson will submit a replacement finger card to the OIC within 14 days of August
2 9, 2011; (3) the OIC's Order No. 10-0126 entered July 14, 2010 revoking Mr. Jepson's licensee
3 will be set aside and vacated; and (4) failure by Mr. Jepson to pay the fine or submit the
4 replacement finger print card by these respective due dates will result in reinstatement of Order
5 Revoking License No. 10-0126 and in revocation of Mr. Jepson's license.


6 5. The parties agree that the Office of Administrative Hearings may return the
7 adjudicative file in this matter to the OIC Chief Hearing Officer and that the subjoined Order
8 may be entered forthwith by the OIC Chief Hearing Officer without further notice to either party.

25 follows:


Stipulation and Order 2

1 1. Licensee Kenneth Jepson is ordered to pay a fine in the amount of two hundred fifty
2 dollars (\$250) within ninety days of August 9, 2011 and to submit a replacement finger print
3 card to the OIC within fourteen days of August 9, 2011.

4 2. Pursuant to RCW 48.17.530 and the foregoing Stipulation, Order Revoking License
5 No. 10-0126 is hereby vacated and set aside. However, in the event Licensee fails to pay the fine
6 or submit the replacement finger print card by the above specified dates, said Order Revoking
7 License will be reinstated and Licensee's Producer License will be revoked.

8 3. OIC Docket Number D 10-0126 is hereby closed and dismissed as settled.
