Pursuant to RCW 34.05.060 and WAC 10.08.230(2)(b), the Office of Insurance Commissioner ("OIC"), by and through its designated representative, Charles Brown, and Nation Motor Club, Inc., by and through its undersigned counsel, Melvin Sorensen, hereby stipulate and agree to resolve this matter as follows:

1. Nation Motor Club, Inc. ("Nation") is a registered protection product guarantee provider in the State of Washington. By letter dated August 24, 2010, the OIC notified Nation of the OIC's intent to revoke Nation's registration for failing to meet a qualification for which issuance of the registration could have been refused had such failure been known to the Commissioner. Pursuant to RCW 48.04.010(1)(b), Nation timely requested a hearing to contest this threatened action.

2. Nation has now transferred its Washington book of business to another registered protection product guarantee provider and Nation has elected to surrender and agrees to surrender its Washington registration.

3. The parties agree that the subject of this hearing is therefore moot, that the adjudicative proceeding file on this matter may be returned to the Chief Hearing Officer of the OIC for entry of a final Order dismissing this matter as settled, and that the subjoined Agreed Order of Dismissal may be entered by the Chief Hearing Officer of the OIC without further notice to either party.




IT IS HEREBY ORDERED that OIC Docket and Hearing Number 10-0165 is hereby closed and dismissed as settled.


