On July 19, 2012, following termination of all prehearing activity, the adjudicative proceeding, and the filing of posthearing briefs in this matter, the undersigned held a posthearing conference herein. The purpose of the posthearing conference was to hear and determine the parties' request for a stay of entry of the Findings of Facts, Conclusions of Law and Final Order in this matter. The basis for the parties' request for a stay is that the issue in this proceeding is similar

to the issue which as of that date was on appeal to (and is now under review, the Washington State Supreme Court having accepted review) the Washington State Supreme Court in *Chicago Title Insurance Co. v. State of Washington, Office of the Insurance Commissioner, No. 87215-5*.


