

This document, just as those biographical affidavits previously filed, contains sensitive and private personal information, and we respectfully request that the OIC maintain this information as confidential and not subject to disclosure under the provisions of RCW 42.56.400 and Executive Order 00-03. Enclosed also are two copies of the redacted version of Mr. Rajamannar's Biographical Affidavit.
- **Tab B.** The original and two copies of the Biographical Affidavit for Harlan A. Levine, M.D. Dr. Levine's Biographical Affidavit is to be included in the biographical affidavits previously filed with the OIC under Exhibit 6 (confidential) to the Form A Statement. This document, just

as those biographical affidavits previously filed, contains sensitive and private personal information, and we respectfully request that the OIC maintain this information as confidential and not subject to disclosure under the provisions of RCW 42.56.400 and Executive Order 00-03.

- **Tab C.** The original and two copies of the Supplement to Biographical Affidavit for Warren Yancey Jobe. Mr. Jobe's Biographical Affidavit was filed with the OIC as part of the biographical affidavits under Exhibit 6 to the Form A Statement. Please include this supplemental statement as an attachment to Mr. Jobe's Biographical Affidavit.
