Dear Mr. George:

Please accept this letter as the Arkansas Insurance Department's ("Department") final approval of Central United Life Insurance Company's ("Central United") Petition to Redomesticate from the State of Texas to the State of Arkansas.

Central United is a Texas domiciled insurer authorized to do business in Arkansas pursuant to Certificate of Authority No. 1151. In accordance with Ark. Code Ann. § 23-63-218(a) and other applicable provisions of law, the Arkansas Insurance Commissioner ("Commissioner") is authorized to permit an insurer organized under the laws of another state and admitted to do business as a foreign-admitted insurer in Arkansas to become a domestic insurer and thereafter be authorized to transact the business of insurance in Arkansas as a domestic insurer. Central United has provided a copy of an order from the Texas Department of Insurance approving Central United's petition to redomesticate from the State of Texas to the State of Arkansas. Central United has also requested authority to maintain its books, records, and assets in Houston, Texas, pursuant to Ark. Code Ann. § 23-69-134, at Central United Life Insurance Company, 10700 Northwest Freeway, Houston, Texas 77092.


The redomestication of Central United from the State of Texas to the State of Arkansas is hereby approved. The enclosed amended Certificate of Authority shall evidence Central United as hereafter being an Arkansas domestic insurance company. Furthermore, Central United's request to maintain its books, records, and assets in Houston, Texas, pursuant to Ark. Code Ann. § 23-69-134, at Central United Life Insurance Company, 10700 Northwest Freeway, Houston, Texas 77092, is also approved. Central United's statutory home office and registered office address in Arkansas will be Central United Life Insurance Company, 425 West Capitol Avenue, Suite 1800, Little Rock, Arkansas 72201.


