Dear Judge Petersen:

Francisco L. Murillo requests a hearing under RCW 48.04.010 on the Order Revoking License entered by the Office of Insurance Commissioner on February 5, 2013, and effective February 25, 2013 (copy enclosed). Because this request is being made before the effective date of the order, the revocation of Mr. Murillo's insurance-producer license is automatically stayed under RCW 48.04.020(1).

Mr. Murillo is aggrieved by the potential revocation of his license. He will request that the Order Revoking License be vacated because it omits critical facts and imposes an unduly harsh penalty that is not proportional to the violations alleged.

Under RCW 48.04.010(5), Mr. Murillo requests that the hearing be presided over by an administrative law judge assigned under chapter 34.12 RCW.

IT IS ORDERED AND YOU ARE HEREBY NOTIFIED that your Washington State insurance producer license is **REVOKED**, effective February 25, 2013, pursuant to RCW 48.17.530 and RCW 48.17.540(2).

THIS ORDER IS BASED ON THE FOLLOWING:

1. Francisco L. Murillo (Mr. Murillo) holds a Washington resident insurance producer license, WAOIC No. 700704, issued January of 2007.
2. Between approximately March of 2009 and December of 2011, Mr. Murillo submitted at least 9 automobile insurance applications which contained a false Washington state address for the proposed insured. The addresses used were those of Mr. Murillo or his family members.
3. Mr. Murillo admitted to an OIC Investigator that he submitted applications for individuals who were not Washington state residents. Mr. Murillo also admitted to using his address for these applications.
4. The subsequent proof of insurance was allegedly used to obtain Washington state driver's licenses.
5. By submitting applications with false information, Mr. Murillo violated RCW 48.17.530(1)(e). The Commissioner may take certain licensing actions including revoking an insurance producer license for such conduct.
6. By submitting applications with false information, Mr. Murillo used fraudulent, coercive, or dishonest practices, or demonstrated incompetence or untrustworthiness thereby violating

RCW 48.17.530(1)(h). The Commissioner may take certain licensing actions including revoking an insurance producer license for such conduct.

7. By submitting applications with false information, Mr. Murillo made a false statement relative to an application for insurance to an insurer thereby violating RCW 48.30.210. The Commissioner may take certain licensing actions including revoking an insurance producer license for such conduct.

IT IS FURTHER ORDERED that you return your insurance producer license certificate to the Commissioner on or before the effective date of the revocation of your license, as required by RCW 48.17.530(4). Return your license to: Licensing Manager, Office of the Insurance Commissioner, P O Box 40257, Olympia, WA 98504-0257.


