
DELEGATION OF AUTHORITY

I, Mike Kreidler, Insurance Commissioner of the State of Washington, make this delegation under the authority granted to the Insurance Commissioner in RCW 48.02.100.

I do hereby delegate to George Finkle authority to serve as presiding officer for administrative proceedings brought in the above styled and numbered matter before my office pursuant to RCW chapter 48.04, 34.05, and other applicable statutes. George Finkle has primary responsibility for the conduct of hearings, the procedural matters related thereto, and direction of the preservation of hearing records. If appropriate under the Administrative Procedure Act, George Finkle may consult with the Chief Deputy Insurance Commissioner (or another staff member designated by the Chief Deputy for specific cases) prior to rendering a summary judgment order or final decision in each case, but George Finkle will finally determine the contents of orders and decisions.

This delegation will not control if the Commissioner determines he will preside over a proceeding, or if the Commissioner makes a different delegation with respect to a specific proceeding.
