On May 31, 2013, the Insurance Commissioner ("OIC") entered an Order Revoking License, No. 13-0179, to Sasha T. Millstein ("Licensee"), revoking her Washington insurance producer's license effective June 18, 2013, based upon the OIC's allegations that the Licensee altered dates on original insurance applications, submitted applications with false information, submitted applications for out-of-state residents using Washington state addresses, and forged the signature

of a notary on insurance documents, in violation of RCW 48.17.530(1)(e), (h) and (j) and RCW 48.30.210. On June 18, 2013, the Licensee filed a Demand for Hearing to contest the OIC's Order, and on July 9, 2013, the undersigned received and filed a Supplemental Demand for Hearing from the Licensee's attorney, Blair M. Russ, Esq., who requested that this matter be presided over by an administrative law judge pursuant to RCW 48.04.010(5). Accordingly, on July 10, 2013 the undersigned transferred this matter to the Office of Administrative Hearings (OAH) for hearing and the entry of an Initial Order.

Subsequently, on February 12, 2013, the undersigned received and filed a copy of the Consent Order Rescinding Revocation Order 13-0179, Stipulation and Agreed Order, executed by the Licensee on January 21, 2014 and the OIC on January 14, 2014, and the Initial Agreed Order closing and dismissing the OAH Docket No. 2013-INS-0004 signed by Administrative Law Judge Robert C. Krabill on February 7, 2014. A copy of the Consent Order, Stipulation and Agreed Order is attached hereto and is by this reference made a part hereof. The OAH administrative law judge subsequently returned the case file to the undersigned on February 26, 2014.

Based upon the above activity,

**IT IS HEREBY ORDERED** that, based upon the Licensee and the OIC having executed the above referenced Consent Order, the parties have fully settled this matter and the proceeding herein, Docket No. 13-0179, is dismissed with prejudice.

ORDER RESCINDING REVOCATION  
ORDER 13-0179, STIPULATION  
AND AGREED ORDER

**I. STIPULATION**

Pursuant to RCW 34.05.060 and WAC 10.08.230(2)(b), the Office of Insurance Commissioner (OIC), by and through its designated representative, Charles Brown, and Sasha Millstein, by and through her counsel, Blair M. Russ, hereby stipulate and agree to resolve this matter as follows:

1. Sasha T. Millstein (Ms. Millstein) held a Washington resident insurance producer license, WAOIC No. 702770, issued July of 2009. Ms. Millstein's license expired in December of 2012.

2. Ms. Millstein acknowledges that she engaged in practices that violate the Washington state insurance code and regulations.

3. In order to resolve the pending proceeding and avoid further costs and expenses in connection with hearings and appeals, the parties agree to settle this matter as follows:

a. Ms. Millstein consents to the entry of this Order, waives any and all hearing rights, and further administrative or judicial challenges to this Order.

b. Ms. Millstein agrees to not to reapply for an insurance producer license in Washington state for ten years from the date this order is entered.

c. Ms. Millstein agrees and understands that should she reapply within the specified time period, the Office of the Insurance Commissioner will deny her application.

The parties agree that the subjoined Order may be entered forthwith and without further notice.




