On September 19, 2013, the Insurance Commissioner ("OIC") sent a letter by electronic mail to Steve Hyson informing him that his application for a Washington resident insurance producer's license had been denied. As evidenced in the OIC's letter, the OIC based its denial on the fact that Mr. Hyson had fairly recently been convicted of a felony, citing RCW 48.17.530(1)(f) which gives the OIC the authority to deny a license if the applicant has been convicted of a felony. In response, on September 19, 2013, Mr. Hyson submitted a Demand for Hearing to contest the denial, asserting he is aggrieved by the OIC's action because it prevents him from working as an insurance producer in Washington and asking that his application for a Washington resident insurance producer's license be granted.

On October 1, 2013, the undersigned held a first prehearing conference in this matter, which included all parties. The OIC was represented by Alan Michael Singer, Esq., Staff Attorney in the OIC's Legal Affairs Division. Mr. Hyson appeared pro se. The undersigned reviewed procedure to be expected at hearing and answered all questions and concerns of the parties. The parties agreed that this hearing should be held on October 15, 2013.

Accordingly, **YOU ARE HEREBY NOTIFIED that a hearing will be held commencing on Tuesday, October 15, 2013, at 10:00 a.m. Pacific Time.** The purpose of this hearing, which will include all parties, is to consider whether Mr. Hyson's application for an insurance producer's license should be denied, granted, or granted with conditions imposed.

The OIC will appear by and through Alan Michael Singer, Staff Attorney in the Legal Affairs Division. Mr. Singer's address is Office of the Insurance Commissioner, Legal Affairs Division, P.O. Box 40255, Olympia, WA 98504-0255 and his telephone number is (360) 725-7046. Mr. Hyson will appear pro se, although he is advised that he may retain an attorney to represent him at any time. Patricia D. Petersen, Esq., Presiding Officer, who serves as Chief Presiding Officer for the Office of the Insurance Commissioner, has been designated to hear and determine this matter. All interested individuals and entities who have questions or concerns concerning this proceeding should direct them to her paralegal, Kelly Cairns, at the same address. The hearing will be held under the authority granted by the Insurance Commissioner under Chapter 48.04 RCW. The basic facts relied upon are those set forth above, which are more specifically included in the OIC's above referenced denial letter and in the Mr. Hyson's above-referenced Demand for Hearing.

The hearing will be governed by the Administrative Procedure Act, Chapter 34.05 RCW, and the model rules of procedure contained in Chapter 10-08 WAC. All parties may be represented at the hearing. They may examine witnesses and fully respond and present evidence and argument on all issues involved.

As required by RCW 34.05.434(2)(i), you are advised that a party who fails to attend or participate in any stage of the proceeding may be held in default in accordance with Chapter 34.05 RCW.

Pursuant to WAC 10-08-040(2) and in accordance with ch. 2.42 RCW, if a limited English speaking or hearing impaired or speech impaired party or witness needs an interpreter, a qualified interpreter will be appointed. There will be no cost to the party or witness therefore, except as may be provided by ch. 2.42 RCW. A Request for Interpreter form is attached to the original of this Notice, with instructions thereon.


