NATURE OF PROCEEDING

On October 22, 2013, Seattle Children's Hospital ("SCH") filed a Demand for Hearing to contest the Insurance Commissioner's ("OIC") approvals of the individual market Exchange filings of Coordinated Care Corporation, Molina Healthcare of Washington, Inc., Premera Blue Cross and Bridgespan Health Company. On November 18, 2013 the undersigned held a prehearing conference which included the OIC, SCH and the three Intervenors, Coordinated Care Corporation, Bridgespan Health Company and Premera Blue Cross. During the prehearing conference the parties indicated they planned to file dispositive motions in this case, and therefore a briefing schedule was discussed. The parties agreed that dispositive motions were to be filed by close of business January 17, 2014; that responses to those motions would be filed by close of business on January 29, 2014; and that oral argument on these motions would be heard by the undersigned commencing at 10:00 a.m. on February 3, 2014. This briefing schedule was orally ordered on November 18, 2013 at the close of the prehearing conference.
