Plaintiff Seattle Children's Hospital (SCH) gives notice that it amends its October 22, 2013 Demand for Hearing because it is no longer pursuing that portion of its demand for hearing involving the Office of the Insurance Commissioner's (OIC's) approvals of the following two individual market Exchange rate request filings:


