
THIS MATTER came before the undersigned on Symetra Life Insurance Company and Symetra National Life Insurance Company's Motion for Protective Order Regarding Exhibit 6-B, Pro Forma Financial Statements. For purposes of this order, the undersigned has considered (1) the Motion for Protective Order, (2) the Declaration of David S. Goldstein, and (3) Exhibit 6-B to each of the applications for redomestication by Symetra Life Insurance Company and Symetra National Life Insurance Company. Exhibit 6-B to each application has been submitted to the Hearing Officer for in-camera review.

Having considered these materials, I conclude that the information contained in each Exhibit 6-B falls within the exemption in RCW 48.02.120(3), which requires that the Office of Insurance Commissioner withhold from public inspection actuarial formulas, statistics, and assumptions submitted to the Commissioner upon his request. In addition, for the reasons stated in the Motion and the Declaration of David S. Goldstein, I find that the elements of a trade secret are met. Accordingly, I conclude that the information contained in each Exhibit

1 6-B falls within the Uniform Trade Secrets Act, chapter 19.108 RCW, and is exempt from  
2 public disclosure on this additional basis.

3 Now, therefore, the undersigned Hearing Officer hereby ORDERS that the Motion for  
4 Protective Order Regarding Exhibit 6-B, Pro Forma Financial Statements is hereby  
5 GRANTED. Each Exhibit 6-B shall be reviewed only in camera by the hearing officer and  
6 shall not be filed in the public record, nor shall these exhibits be quoted orally or in writing, or  
7 otherwise placed in the record.
