Global Warranty Group, LLC (“GWG”) and Wireless Protection Program Association (“WPPA”), together referred to herein as “Respondents” or “Companies”, by and through their undersigned counsel, hereby respectfully submit their Notice of Non-Appearance At Hearing in the above-captioned matter, and offer the following by way explanation.

Respondents, Global Warranty Group, LLC and Wireless Protection Program Association are the remaining Respondents in the above-captioned Matter No. 14-0117, all other respondents having been dismissed upon Order of the Presiding Judge herein dated November 3, 2014.

Both Global Warranty Group, LLC and Wireless Protection Program Association have gone out of business, have closed their offices, and have ceased all business operations in all states.

1 The Companies are in the process of formally dissolving their respective
2 corporate or business structures, and are also in the process of preparing and filing
3 voluntary bankruptcy proceedings in their respective jurisdictions.

4 The Companies have terminated all employment relationships with all former
5 employees, officers, and directors of the Companies.

6 The Companies have terminated all business relationships, including all
7 administrative and service agreements, with persons or entities with which the
8 Companies formerly did business.

9 The insurers that had provided the contractual liability insurance policy
10 coverage for the products and services offered by the Companies have terminated their
11 insurance and administrative agreements with GWG and have replaced GWG with
12 other administrative service companies for the business previously administered by
13 GWG.

14 GWG and WPPA have incurred substantial debt related to this Matter, and do
15 not have any funds or other financial resources of any kind either to satisfy that debt
16 already incurred, or to continue the defense of this Matter and incur further debt.

18 Accordingly, Respondents Global Warranty Group, LLC and Wireless
19 Protection Program do hereby respectfully advise the Honorable Presiding Judge and
20 the Office of the Insurance Commissioner that Respondents are unable and without
21 means to appear, and, therefore, will not appear, at the Hearing on this above-captioned
22 Matter No. 14-0117 currently scheduled for December 5, 2014.


