This case comes before me on the Driscolls' February 2, 2015, Petition for Reconsideration of Order on OIC Staff's Motion for Summary Judgment.

I issued an Order in this matter, filed January 23, 2015, granting the OIC Staff's Motion for Summary Judgment and dismissing the Driscolls' September 19, 2014, Demand as a matter of law.

RCW 34.05.470(1) provides that within ten days of the service of a final order, any party may file a petition for reconsideration, stating the specific grounds upon which relief is requested. My January 23, 2015 Order was a final order. The Driscolls' February 2, 2015 Petition for Reconsideration was timely under RCW 34.05.470(1) and stated the specific grounds upon which they requested relief. I have considered the Driscolls' Petition for Reconsideration on the merits and dispose of it pursuant to RCW 34.05.470(4).

The Petition for Reconsideration is denied.


