
This matter comes before me on OIC's Motion for Clarification and Reconsideration of Order on Commonwealth Insurance Company of America's Motion for Protective Order. I have considered the Motion, filed December 18, 2014, and Commonwealth's Opposition, filed December 19, 2015. The OIC seeks: 1) clarification of the directive in my Order on Commonwealth's Motion for Protective Order, filed December 9, 2014, that the "Pro-Forma Financial Statement shall not be filed in the public record"; and 2) reconsideration of the finding that the document contains trade secrets.

Order.

1. The December 9, 2014, Order was intended to require that the Pro-Forma Financial Statement not be posted online, for the reasons stated. I assume that if the OIC receives a public records request related to the Pro-Forma Financial Statement, it will comply with any notice requirements prior to release. *See, Order, at Para. 9.*

2. Except as provided in Paragraph 1 of the present Order, the OIC's Motion for Reconsideration is denied.
