**OIC HEARINGS UNIT ACTION TO DATE:** Prehearing Conference held January 8, 2015. Notice of Hearing filed January 8, 2015, setting the evidentiary hearing for April 1-2, 2015. Order on Motion to Transfer to ALJ, ordering transfer to OAH, filed March 30, 2015.

**AGENCY REQUEST:** Please assign an ALJ as soon as possible. Because Mr. Timmer requested transfer to OAH just nine days before the originally-scheduled evidentiary hearing and hearing preparation should be complete, the evidentiary hearing should be held at the earliest date available on the ALJ's schedule that is reasonably convenient for parties and counsel, but not delayed by discovery, motions, etc. The ALJ should enter Findings of Fact, Conclusions of Law, and Initial Order as soon as possible after the evidentiary hearing, then return the original file and hearing record to the OIC Hearings Unit for entry of a final order.

If this matter is settled before the evidentiary hearing, please promptly return the hearing file, including the settlement documents, to the OIC Hearings Unit. The OIC Presiding Officer will then review the file and enter a Final Order Terminating Proceeding.

The OIC's Order Revoking License is stayed pending the final order.

**OTHER INFORMATION:** 1) The OIC requires insurance agents and brokers who are the subjects of disciplinary matters to appear in person at evidentiary hearings. 2) If the ALJ permits any party or its attorney to appear by telephone, both parties and their attorneys) should appear by telephone, so one party/attorney is not alone with the ALJ. 3) Hearings should be held in Olympia, absent important reasons for another venue.


