**11.1 Whether the OIC Staff has issued data or information requests to Kaiser,
Parent, GHC or GHO, and if so, the nature and number of those requests.**

The OIC issued requests for information to Kaiser Foundation Health Plan of
Washington ("Kaiser") on March 24, 2016 pertaining to the acquisition of Group Health
("Form A Filing").

11.2 The status of Kaiser, Parent, GHC and GHO responses to any requests.

GHC understands that Kaiser is in the process of responding to the requests. GHC will cooperate, as needed, with Kaiser in the preparation of those responses.

11.3 Plans of the OIC Staff to issue data and information requests to Kaiser, Parent, GHC and GHO in the future.


