The Licensee, Cristen Loree Marceau, requested a hearing in this matter. On May 24, 2016, the parties notified the Office of Administrative Hearings that they have resolved all issues raised in the hearing request. More specifically, the parties entered into a Consent Order Revoking License entered May 24, 2016. By means of this document, Ms. Marceau withdrew her request for a hearing and waived "any and all hearing or other procedural rights". Moreover, Ms. Marceau requested that the Office of Administrative Hearings issued "an Order Terminating Proceedings in this matter".

I characterized the Insurance Commissioner's Consent Order revoking license as a Final Order. Accordingly, I determined that I lacked jurisdiction to issue an administrative order. Therefore, on or about May 26, 2016, I issued a Notice of Case Closure. I was advised on June 20, 2016, that the Insurance Commissioner's appellate process requires a Final Order in this circumstance. Thus, I issue this Final Order Dismissing Appeal, supplanting the Notice of Case Closure issued earlier.

Based on the case file and the Consent Order Revoking License, no issue remains for resolution by the Office of Administrative Hearings. Accordingly, this matter should be and is hereby DISMISSED.


Now, Therefore,


