On January 18, 2007, the Insurance Commissioner (Commissioner) entered an Order to Cease and Desist, No. D06-377, which was appealed by Dayspring Management, LLC, Premier Club Benefits, Premier Club Services, RJ Wilson and Associates, LTD, Medical Benefits Administrators of Maryland, Inc., and Ronald Jack Wilson by Request for Hearing filed on February 6, 2007. The subject Order was supplemented by the Commissioner by Notice of Hearing to Request Imposition of a Fine and to Determine Premium Taxes and Penalties Due filed on February 21, 2007. Said Order and Notice are together the subject of this appeal.

Accordingly, on February 16, 2007, the undersigned held a first prehearing conference in this matter. The Commissioner was represented by Charles D. Brown, Esq., Senior Staff Attorney in his Legal Division. All Entities and Individual were represented by Timothy Parker, Esq. of Seattle, Washington, Edward Wender, Esq. of Baltimore, Maryland and Daniel Zollner, Esq. of Chicago, Illinois.

During said prehearing conference, the parties agreed that there is no stay of the Commissioner's Order to Cease and Desist, which is the subject of this appeal, and therefore all Entities and Individual must be in compliance with all terms of said Order as of its effective date of January 18, 2007; **except that the Entities and Individual do have the authority, until entry of the final order on hearing and then only if allowed by that final order, to collect fee contributions paid by the participants and the ability to adjudicate and pay claims.**

Further, during said prehearing conference, the Commissioner and the Entities and Individual agreed that they should have until June 11, 2007 to conduct discovery and all preparation for the hearing in this matter. The Commissioner and the Entities and Individual further agreed that they should present and argue dispositive motions on June 11, 2007. If necessary as a result of rulings made on said dispositive motions, the hearing in this matter shall be scheduled to commence shortly thereafter.

IT IS HEREBY ORDERED that the Commissioner and the Entities and Individual shall file all dispositive motions with the undersigned on or before close of business on May 31, 2007.

IT IS FURTHER ORDERED that all dispositive motions of the Commissioner and the Entities and Individual shall be presented to the undersigned and argued on **June 11, 2007, commencing at the hour of 9:00 a.m., in the Office of the Insurance Commissioner, 5000 Capitol Boulevard, Tumwater, Washington, hearing room 221.**
