The purpose of this Amended Order Consolidating D07-305 & D07-309 into D07-309 is solely to add the underlined text as shown below. With the addition of the text, the original Order Consolidating D07-305 & D07-309 entered on March 10, 2008, remains effective in its entirety as of date of entry.

On January 25, 2008, the Insurance Commissioner (Commissioner) filed a Notice of Hearing in matter No. D07-305, alleging Pacific Northwest Title, by and through its agent Cascade Title, violated WAC 284-30-800. As stated in the Notice of Hearing, pursuant to RCW 48.05.185, the Commissioner seeks to impose a fine against Pacific Northwest Title in the amount of \$10,000.00.


On January 25, 2008, the Insurance Commissioner filed a second Notice of Hearing in matter No. D07-309, alleging Pacific Northwest Title, by and through its agent Clark County Title, violated WAC 284-30-800. In the Notice of Hearing, the Commissioner requested a sanction of a fine against Pacific Northwest Title in the amount of \$5,000.00, pursuant to RCW 48.05.185.


