On July 14, 2005, the Hearings Unit received and filed a Demand for Hearing and Notice of Appeal of Revocation of Certificate of Authority No. 1746. A prehearing conference was held on August 10, 2005, setting a hearing date in this matter for October 10, 2005. Charles Brown, Sr. Staff Attorney, Legal Affairs, represented the Insurance Commissioner (OIC). Leonard Dome, Esq. and Saya Teraoka, Esq. of Mound, Cotton, Wollan and Greengrass of New York City, represented Trenwick America Reinsurance Corporation (TARCO).

Subsequently, a request for continuance was granted to the OIC, for good cause shown, and the hearing date was continued until November 8, 2005.


On Friday, November 4, 2005, a second request for continuance was made by the OIC. The OIC was represented by Deputy Commissioner Carol Sureau. Mr. Dome, Ms. Teraoka and Derek Wooley, Consultant, were present for the motion on behalf of TARCO. The basis for the motion was that both parties were in agreement to a settlement of this case, but additional time was necessary. Said motion was granted.

On January 9, 2006, the OIC filed an Order Rescinding Order Revoking Certificate of Authority No. 1746 and on that same date also filed an Order Suspending Certificate of Authority No. 1746. The parties advise that this activity is in settlement of this matter. Said Order Rescinding and Order Suspending are included in the hearing file and are by this reference incorporated herein.

Based upon the above activity,

**IT IS HEREBY ORDERED** that this proceeding is terminated with prejudice.
