**STIPULATION AND ORDER TO
AMEND FIRST PRE-HEARING
ORDER**

I. STIPULATION

On April 16, 2008, Alan Michael Singer substituted for Marcia Stickler. Accordingly, to accommodate Mr. Singer, and in accordance with WAC 10-08-090, Chicago Title Insurance Company stipulates and agrees to amend the April 1, 2009 First Pre-Hearing Order (herein "Order") as follows:

 - 13 ■ The date for exchange of exhibits is November 19, 2008.
- 14 ● The hearing of witness testimony on Phase I, as needed, may be changed from
15 September 17, 2008 at 9:30 a.m. to December 3, 2008 at 9:30 a.m.
- 16 ● The date for issuing a ruling on the agency/phase I issue may be changed from
17 October 1, 2008 to December 17, 2008.

18 PHASE II

- 19 ● In Phase II, the Discovery Cut Off may be changed from December 1, 2008 to
20 February 18, 2009.
- 21 ● In Phase II, the Motions calendar deadlines may be changed as follows:
- 22 ○ As to the deadline for all motions and briefs related to the issue of expenditures
23 by Land Title Company of Kitsap County, Inc., the deadline for filing all such
motions may be changed from January 28, 2009 to March 11, 2009;
 - The deadline for response briefs may be changed from February 11, 2009 to
March 25, 2009;


