**RCW 48.135.090 specifies that the Commissioner shall appoint an insurance fraud advisory board. The board shall consist of 10 members. Five members shall be representatives from the insurance industry doing business in the state, at least one of which shall be from a Washington domestic insurer, two members shall represent consumers, one member shall represent the National Insurance Crime Bureau or successor organization, one member shall represent prosecutors, and one member shall represent other law enforcement agencies.**

American consumers lose \$308.6 billion each year to insurance fraud theft, according to a recent study from the Coalition Against Insurance Fraud. Up to 10 percent of insurance claims are estimated to be fraudulent.

Insurance fraud is not a victimless crime. We all pay for it through increased insurance premiums.

I work with our Insurance Fraud Advisory Board to protect and educate consumers about the costs of insurance fraud.

Established by state law and at the direction of Commissioner Kreidler, the Criminal Investigations Unit (CIU) investigates criminal insurance fraud in Washington state. This includes a team of Detectives, Criminal Analysts, Prosecutors, an Administrative Assistant, and an Office Assistant.

CIU has earned law enforcement accreditation from the Washington Association of Sheriffs and Police Chiefs.

## CRIMINAL INVESTIGATIONS UNIT

### Mission Statement

Our mission is to identify, investigate and bring to prosecution criminal organizations and individuals who victimize the insurance industry.

## Interagency Partnerships

Our unit continues to work with federal, state, and local law enforcement and regulatory agencies to identify, investigate and prosecute criminal organizations and individuals engaged in fraud that targets the insurance industry.



## Media and Outreach

Along with a strong partnership with community organizations and law enforcement agencies committed to fighting fraud, CIU engages with the media, civic organizations, and other law enforcement agencies in order to educate Washington state consumers on insurance fraud.

Detectives connect with various groups each year to establish relationships and to provide education on CIU's mission statement and identifying insurance fraud to further protect Washington consumers.

Between January 2020 and December 2022, CIU detectives and the director attended and presented at eight outreach events. This is considerably less than in previous years due to the pandemic, but the unit was still able to convey its message.

# Spokane man found guilty of insurance fraud for the second time in Spokane County Superior Court



**Ivan Kriger** was found guilty of insurance fraud for a second time in August 2022 in Spokane County Superior Court.

Kriger (also known as Evaun Syrah Solomon), of Spokane, was recently convicted of insurance fraud after Insurance Commissioner Mike Kreidler's Criminal Investigations Unit (CIU) completed a second criminal investigation into his filing of false insurance claims. Kriger pled guilty to another charge of filing false claims after he was found guilty by a jury earlier this year.

In this case, CIU's investigation found that Kriger submitted a claim for damages to the City of Spokane for a paved parking lot he owned. Kriger stated that a contractor the city hired to remove another building parked in his parking lot caused catastrophic damages. He claimed the amount to repair the parking lot would be \$279,680.44. The city submitted the claim to Alaska National Insurance Company, which completed an investigation and found that the parking lot had been in disrepair for years and there were no new damages as Kriger had alleged.

# Former insurance agent pleads guilty to \$2.8 million theft



**Edward J. Chadwick**, of Yakima, pleaded guilty to first-degree theft in Spokane County Superior Court involving 24 insurance premium finance loans. Chadwick was ordered by the court to report to the Spokane County Jail by Oct. 1 to serve 30 days of confinement. He must also pay \$600 in court fees and \$847,795 in restitution to a Spokane premium finance company.

Charges against Chadwick were brought after an investigation by Insurance Commissioner Mike Kreidler's Criminal Investigations Unit (CIU).

Chadwick was an insurance producer and owned an insurance agency called Kelt, primarily selling insurance to transportation companies. He is accused of fraudulently obtaining 24 insurance premium finance loans totaling \$2.8 million from April 2016 through July 2018 from Tepco, a premium finance company based in Spokane. He is accused of obtaining loans on behalf of several fake trucking companies for commercial policies that didn't exist. He also obtained loans on behalf of one real trucking company, a former client, without the client's knowledge.

## RCW 48.135.050 – Disclosing insurance fraud

“(1) Any insurer or licensee of the commissioner that has reasonable belief that an act of insurance fraud which is or may be a crime under WA law has been, is being, or is about to be committed shall furnish and disclose the knowledge and information to the commissioner...”



## Insurance fraud

The act or omission committed by a person who, knowingly, and with intent to defraud, commits, or conceals any material information ...

## Fraud Referred to the Commissioner

Before an investigation becomes a case, it's a referral — a questionable insurance claim submitted to the OIC for review. Insurance companies refer questionable claims as required by RCW 48.135.050. From January 1, 2020 to December 31, 2022, a total of 8,615 fraud referrals were submitted to the OIC.

The OIC receives referrals through three main sources: the National Insurance Crime Bureau, the National Association of Insurance Commissioners, and online reports from the public, other agencies, or law enforcement.

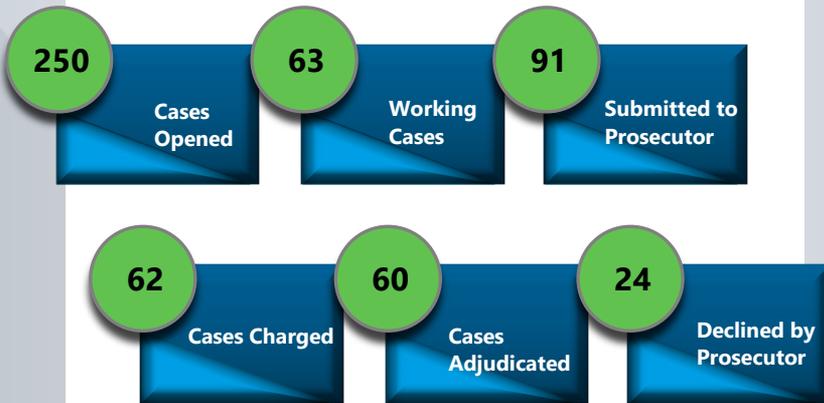

# Criminal Investigations

CIU conducts criminal investigations of individuals and organizations who engage in fraud targeting insurance companies.

From January 1, 2020 to December 31, 2022, CIU opened 250 criminal cases. The majority of these were for personal property or property damage and bodily injury loss claims made to insurance companies.
