**You must call in to the conference. If you fail to call in, the presiding officer may hold you in default and dismiss your appeal. RCW 34.05.440(2)**

If you are unable to call in, you may request a continuance of the Prehearing Conference. A request must include a reason. The continuance will only be granted if you can show good cause.


