Please announce yourself as you join the conference. Make sure your phone has reception and is charged to last at least an hour, and that you are in a quiet place where you can hear and be heard clearly.

You must call in to the conference. If you fail to call in, the presiding officer may hold you in default and dismiss your appeal. RCW 34.05.440(2)

If you are unable to call in, you may request a continuance of the Prehearing Conference. A request must include a reason. The continuance will only be granted if you can show good cause.


