Mr. Freeman,

I am in receipt of the Demand for Hearing Presided Over By Administrative Law Judge, RCW 48.04.010(1)(b) and (5). I have cc'd the OIC Hearings Unit.

OIC objects to ACLDN's request that the hearing be presided by an administrative law judge ("ALJ") under Chapter 34.12 RCW.

ACLDN is not entitled to a hearing at the Officer of Administrative Hearings. Pursuant to RCW 48.04.010(5), "**A licensee under this title** may request that a hearing authorized under this section be presided over by an administrative law judge assigned under chapter **34.12 RCW**" (emphasis added).

ACLDN is not a licensee under Title 48 RCW. Therefore, it has no right to review by an ALJ or to rely on this provision. OIC's position is the case shall be heard by the Presiding Officer as with any other unauthorized insurance cases.
