An examination of the financial condition of **SAINT MARTIN'S UNIVERSITY** (SMU) as of June 30, 2008 was conducted by examiners of the Washington State Office of the Insurance Commissioner (OIC). SMU holds a Washington certificate of exemption to issue charitable gift annuities. This examination was conducted in compliance with the laws and regulations of the state of Washington and in accordance with the procedures promulgated by the National Association of Insurance Commissioners and the OIC.

IT IS FURTHER ORDERED THAT, SMU file with the Chief Examiner, within 90 days of the date of this order, a detailed report specifying how SMU has addressed each of the requirements of this order.
