# Free or low-cost health care coverage options





## Affordable Care Act and what it means for you

The Affordable Care Act (ACA) requires most people to have health insurance. If your employer doesn't provide health insurance, you'll need to buy your own individual health plan during the annual open enrollment period. The good news is that if you're under age 65 and don't have insurance or you're struggling to pay for your insurance, you may qualify for help to pay for some or all of your premium. In addition, health insurers cannot limit or deny you coverage if you have a pre-existing condition.

# Free or low-cost health care coverage options

Apple Health provides medical, dental, vision and mental health coverage to people of all ages who qualify. There's no open enrollment period, so you can apply throughout the year through Washington Healthplanfinder at www. wahealthplanfinder.org.

# Apple Health for Workers with Disabilities Program is for people with disabilities age 16 through 64 who meet

federal disability requirements and are employed. You must meet income limits. You can buy medical coverage on a sliding-fee scale. Find out more at www.dshs. wa.gov/esa/community-services-offices/apple-health-workers-disabilities-hwd-program or call 1-800-871-9275 (in Seattle call 1-206-272-2169).

**Apple Health for Pregnant Women** offers medical coverage for pregnant women who meet income limits, and full medical benefits for the newborn baby for the first year. To apply, go to www.wahealthplanfinder.org.

Washington Healthplanfinder may offer you help paying your premiums for an individual health plan, if you qualify. Open enrollment occurs each year Nov. 1 - Jan. 15. For coverage to start Jan. 1, you must buy a plan Nov. 1 through Dec. 15. For coverage to start Feb. 1, you must buy a plan from Dec. 16 through Jan. 15. Remember, premium and cost-sharing subsidies are only available through the Exchange. You can buy a plan through the Exchange during open enrollment even if you don't qualify for premium and cost-sharing subsidies. Always check with your insurance company to make sure you know when your coverage starts.

If you qualify for Apple Health, you can enroll in Washington Apple Health all year long at www.wahealthplanfinder.org.

#### Individual health plan open enrollment

Open enrollment occurs each year Nov. 1 - Jan. 15. For coverage to start Jan. 1, you must buy a plan Nov. 1 through Dec. 15. For coverage to start Feb. 1, you must buy a plan from Dec. 16 through Jan. 15.

If you miss the annual open enrollment period, you can still enroll if you qualify for Apple Health (www. hca.wa.gov) or a special enrollment period (www.insurance.wa.gov).

#### Military and veterans

**TRICARE for Life** provides health insurance for qualified service members, National Guard and Reserve members. To find out more, go to www.tricare.mil or call 1-888-874-9378.

**Veterans Affairs (VA)** benefits may be available to veterans who qualify for care and prescription drug coverage through a Department of Veterans Affairs medical facility. To find out if you qualify, go to www.dva.wa.gov or call 1-800-562-2308.

#### **Tribal members**

Washington Healthplanfinder may offer you free or low-cost health insurance if you're under age 65, not on Medicare, and you're a tribal member of a federally-recognized tribe or a shareholder in an Alaska Native Corporation. Learn more about what options are available at www.wahbexchange.org/new-customers/who-can-sign-up/tribal-members/

Indian Health Service is a federal program for American Indians and Alaska natives. It also may provide health services to Indians of Canadian or Mexican origin or to non-Indian women pregnant with an eligible American Indian child. **Tribal clinics** offer health care to tribal members and their families. In some smaller communities, tribal clinics may serve the entire community. For more information, contact your local tribal government or go to www.npaihb.org/member-tribes/.

#### **Health clinics**

#### **Health care programs**

**Aged, Blind or Disabled Cash Assistance Program** provides a monthly cash grant to people age 65 or older, blind or who have a long-term medical condition that's likely to meet federal disability criteria. **Direct health care practices** do not use insurance. The health care providers charge a set monthly fee for all primary care delivered in their offices, regardless of the number of visits. **Discount prescription plans** are membership groups that may charge a fee for a list of products.

**Disease specific support groups**, such as the Kidney Foundation, the Multiple Sclerosis Society and the American Cancer Society may be able to provide help with costs. Go online for contact information.

**Early Intervention Program (EIP)** provides services to help eligible people with HIV get the medications and assistance with insurance premiums.
