An examination of the financial condition of **HEALTH ALLIANCE NORTHWEST HEALTH PLAN, INC.** (HANHP) as of February 8, 2013 was conducted by examiners of the Washington State Office of the Insurance Commissioner (OIC). HANHP has applied for a Washington certificate of registration as a health care service contractor (HCSC).
