Initial APCD Analysis Findings



Criteria

- Services provided from 2019 2022 (currently through Sept. 2022)
- Fully-insured commercial market (small number of self-insured claims)
- Place of service code 41 (Land ambulance)
- Excluded denied claims
- State of rendered service limited to WA (for ambulance services, often reported as provider's location)



Comments from last advisory group meeting

- Denied claims
 - Negligible number of denied claims reported
- Treatment but no transport code (A0998)
 - Negligible number of claims with A0998 reported
- Specialty Care Transport code (A0434) broken out separately



Definitions and calculations

- Ownership status
 - Based on ownership database constructed by Loren Adler and colleagues
- Transport type
 - Emergency, nonemergency, specialty care transport
- Potential surprise bill
 - The difference between the billed charges and the allowed amount for OON transports
- Enrollee cost sharing
 - Sum of deductibles, copayments and coinsurance






Average charged amount for in-network and out-of-network ground ambulance services, 2019 - 2022





Prevalence of out-of-network utilization, by ambulance ownership type, 2019-2022






Prevalence of potential surprise bills, 2019-2022


The percent of services that were out-of-network and the allowed amount was less than the full charge (allowed amount = insurer paid amount + enrollee cost sharing amount)






Average magnitude of potential surprise bills for emergency advanced life support level 1, 2019-2022

Carrier Survey Feedback



Question	OIC Response
Can carriers who are part of the same holding company submit a single survey response?	Carriers who are part of the same holding company may submit a single survey response. The survey will ask whether the responses differ across carriers, and if so, carrier specific responses will be requested.



Question	OIC Response
Can you use a percent change indicator for questions #9 – 13 (questions about how billed charges and allowed amounts have changed over the past 5 years) so responses can be compared across carriers?	A percent change indicator will be added to be able to better compare responses across carrier submissions.



Question	OIC Response
Will you ask for additional information about the ground ambulance providers that the carriers have contracts with? Such as ownership status (public, private, etc.).	An additional breakout will be added to question 1, 2 and 3 (questions about the number of ground ambulance providers the carriers contracted with) requesting the total number contracted ground ambulance providers by ownership status (public, private)
