BACKGROUND

An examination of the financial condition of **TRINITY WESTERN UNIVERSITY FOUNDATION - U.S.** (TWUF) as of December 31, 2013 was conducted by examiners of the Washington State Office of the Insurance Commissioner (OIC). TWUF holds a Washington certificate of exemption to issue charitable gift annuities. This examination was conducted in compliance with the laws and regulations of the state of Washington and in accordance with the procedures promulgated by the National Association of Insurance Commissioners and the OIC.

The examination report with the findings (see Exhibit A) was transmitted to TWUF for its comments on June 3, 2015. TWUF's response to the report is attached to this order (see Exhibit B) only for the purpose of a more convenient review of the response.
